Supply Chain Act

From 2023, the due diligence audit will come into force through the Supply Chain Act.

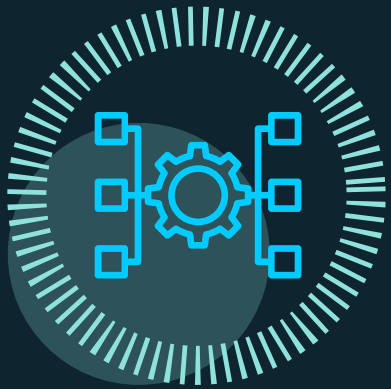


Which companies are affected?

- Large German companies with **more than 3,000 employees**: *January 2023*
- Companies with **more 1000 employees**: *January 2024*
- EU draft: Companies with **more than 250 employees and sales of more than 40 million euros** if they generate more than half of their sales in an "at-risk" sector

Supply Chain Act II

From 2023, the due diligence audit will come into force through the Supply Chain Act.



Which industries are affected?

- **All industries** need to comply with the Supply Chain Act, the already regulated ones like banks and insurances, as well as all other industries like retail, wholesale, manufacturers, consulting

Which suppliers of a company are affected?

- **All suppliers** of a company are affected, from the product supplier, to the maintenance and consulting service supplier

Supply Chain Act III



What are the consequences of non-compliance?

- Fines of up to 800,000 euros or 2% of annual sales for companies with sales of more than 400 million euros
- Exclusion from public tenders for up to three years



What are the obligations under the Supply Chain Act?

- Risk management system and analysis
- Policy statement on human rights
- Establishment of a compliant procedure
- Documentation of the fulfillment of due diligence + annual transparent reporting
- Introduction of preventive measures
- Taking corrective action



Supply Chain Act IV

The German Supply Chain Act refers to some extent to the ESG regulation, mainly the Social part and few aspects of Environmental and Governance.

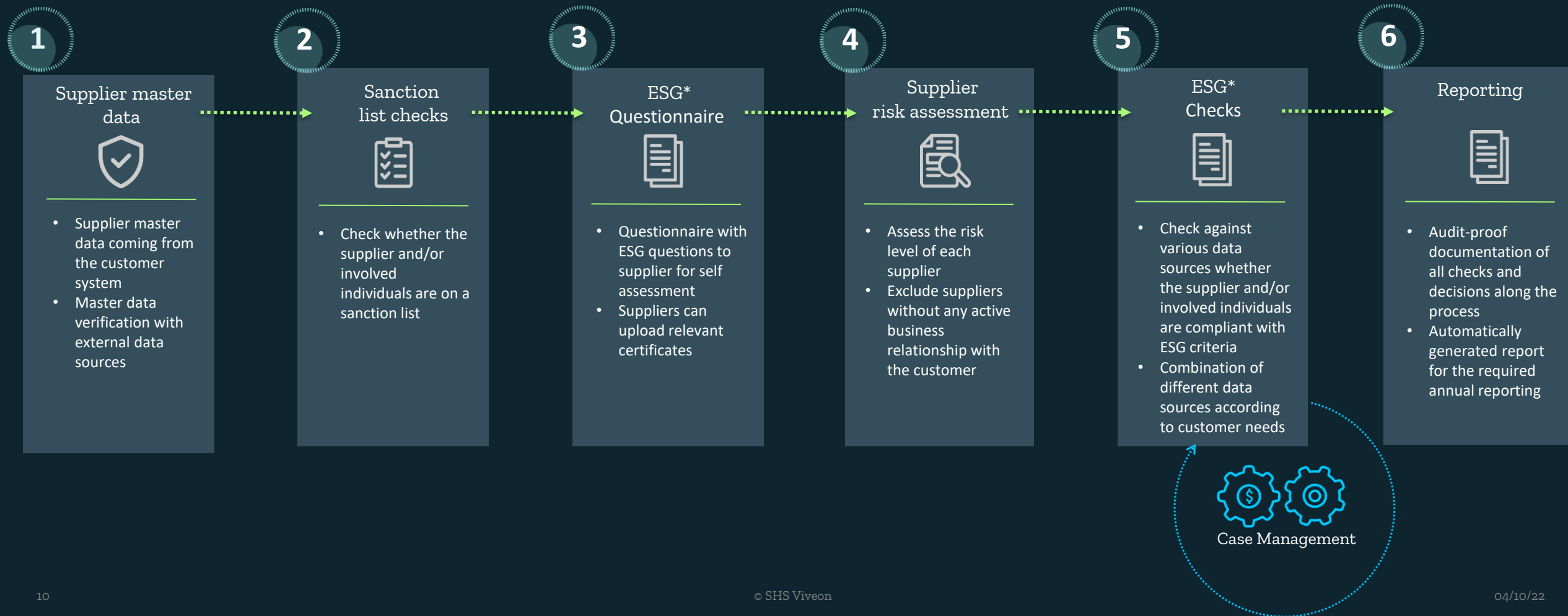
What are the main challenges for a company in the implementation of the supply chain act

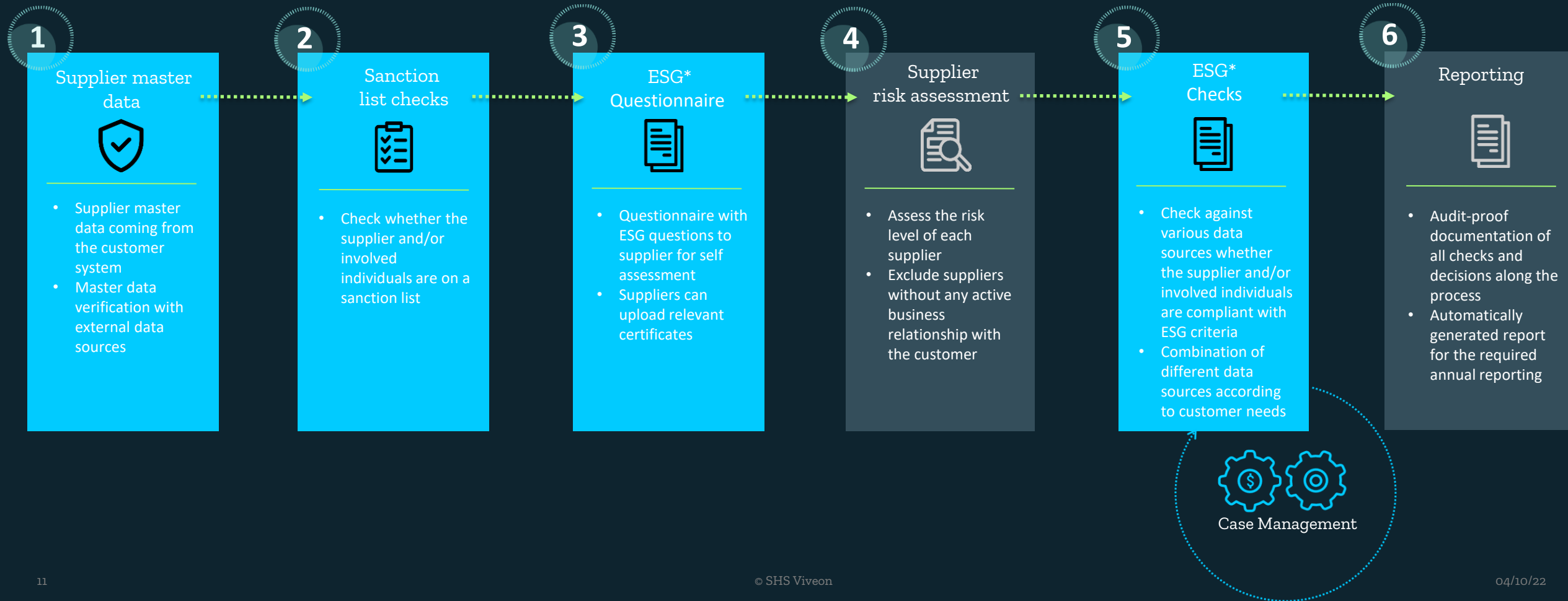
Process flow end-to-end

Process flow focusing on the German supply chain act (Lieferkettengesetz)

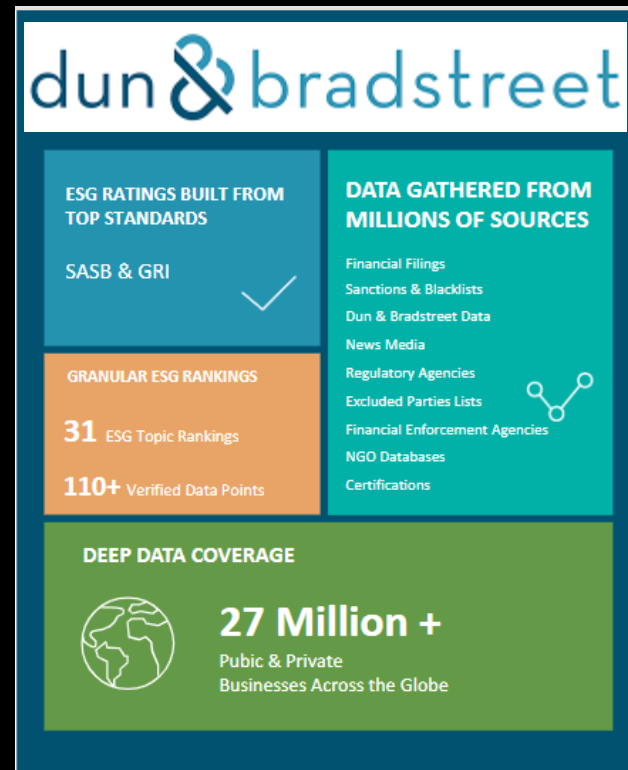

Dun and Bradstreet is currently the data provider for sanctions list and provides an ESG score that is based on millions of data gathered by Dun and Bradstreet. The score goes from 1 – very good to 5 – poor ESG level.

ESG* Checks

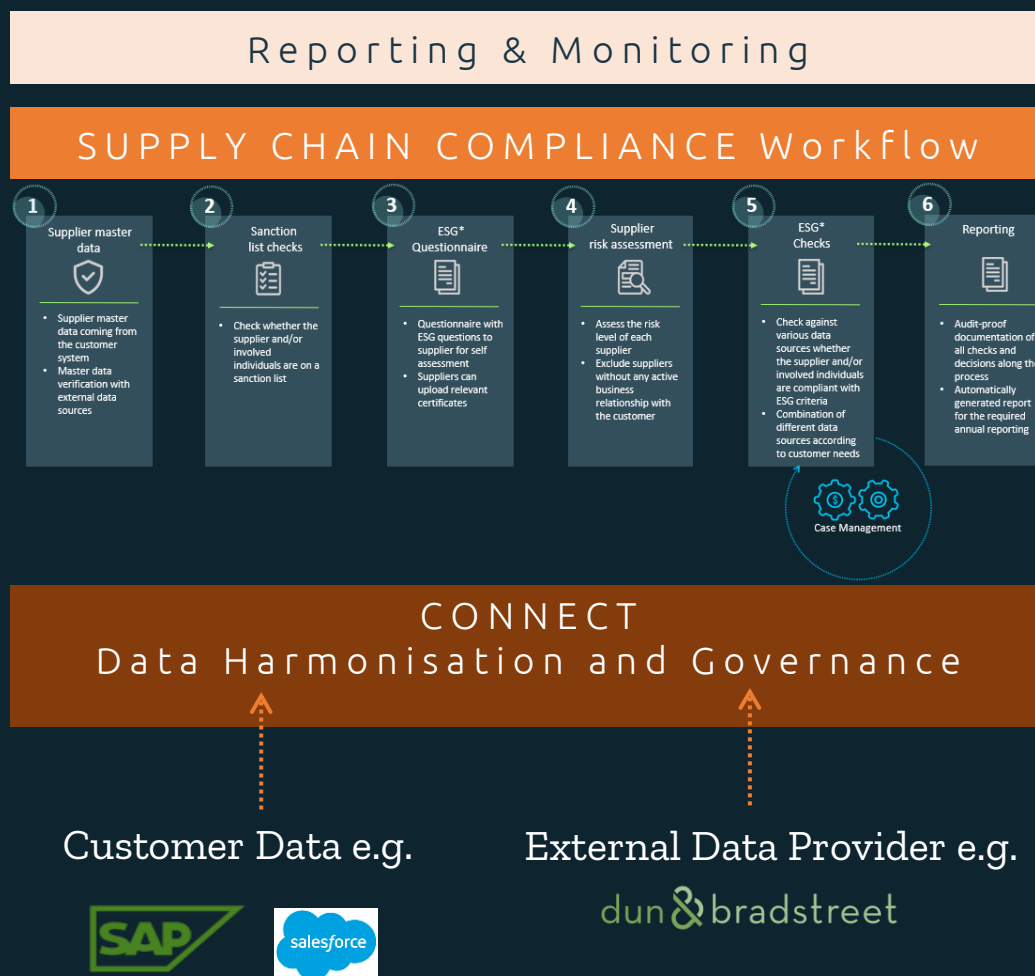


- Check whether the supplier and/or involved individuals are compliant with ESG criteria
